# **Modern Slavery Act Statement**

This statement is made pursuant to section 54 of the Modern Slavery Act 2015 to confirm Cyient's commitment to ensuring that slavery and human trafficking do not exist in any part of its business or supply chain. This statement updates Cyient's prior statement through the financial year ending March 31, 2023. It has been approved by the Board of Directors of Cyient Europe Limited and signed by its Managing Director John Renard.

# **Organization Structure**

It is a wholly owned subsidiary of Cyient Ltd, a publicly traded company listed on the Indian stock exchanges and headquartered in Hyderabad, India. This statement is made on behalf of Cyient Europe Limited and its parent, subsidiaries, and affiliated entities.

Cyient does not condone modern slavery practices in its supply base. Specifically, Cyient's Vendor Code of Business Ethics and Conduct requires all vendors to comply in all respects with our modern slavery policies. Further, the vendors are required to acknowledge their commitment to the same.

# **Reporting Mechanisms**

In addition to the oversight of Cyient's operations, Cyient engages with its work force and customers on-site to ensure that violations of law and human rights does not occur. There are reporting mechanisms available to Cyient Associates, its vendors and the vendors' employees and subcontractors, to raise specific concerns - specifically through Cyient's anonymous, confidential and externally managed whistleblowing hotline. This resource can be used by Associates and vendors to raise any issue including issues relating to modern slavery and human trafficking, and will provide them with guidance on how they should respond, if they identify any suspicious activity.
