- I, Manish Kumar Singhania, Practicing Company Secretary, at # Flat No. 402, 4th Floor, Mahadev residency, Irrum Manzil, Hyderabad 500082, was appointed as scrutinizer by the Board of Directors of CYIENT LIMITED (the Company) vide its duly held Board Meeting dated 23.01.2025 for the purpose of scrutinizing the e-voting process (remote e-voting) pursuant to Section 108 and Section 110 of the Companies Act, 2013 read with Rule 20&22 of the Companies (Management and Administration) Rules, 2014 (Amendment Rules, 2015) Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, in respect of the below mentioned resolutions conducted by way of Postal Ballot process through remote Electronic voting, in a fair and transparent manner.
- 1. The compliance with the provisions of the Companies Act, 2013 and the Rules made thereunder and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, relating to voting through electronic means by remote e-voting) by the shareholders, on the resolutions as mentioned in the Notice of Postal Ballot dated 23.01.2025, is the responsibility of the management. - 2. The Remote e-voting facility was provided by Kfin Technologies Limited.
- 3. In accordance with the Notice dated 23.01.2025 sent to the shareholders on 13.02.2025 the remote e-voting commenced at 9.00 A.M. on 14th February 2025 and ended at 5:01 PM on 15th March 2025.
- 4. The Equity Shareholders holding shares as on 07.02.2025, "cut-off date", were entitled to vote on the resolution stated in the Notice



- 5. As stated in Sub-rule 3 of Rule 22 of Companies (Management and Administration) Rules, 2014 as amended from time to time & MCA circulars, on 14.02.2025, public notices were published by the Company in Business Standard, All India Edition ('English Newspaper') and in Mana Telangana, Hyderabad Edition ('Telugu Newspaper') informing about the completion of dispatch of Postal Ballot notices to its shareholders through electronic means, along with all requisite document.
- 6. After closure of e-voting at 5.00 PM on 15.03.2025, the votes cast through remote e-voting were unblocked at 5.01 PM on 15.03.2025 and downloaded from the e-voting website of Kfin Technologies Limited (https:// https://evoting.kfintech.com/) in the presence of two witnesses, who are not in the employment of the company. The e-voting data/results downloaded from the e-voting system of Kfin Technologies Limited were scrutinized and reviewed, the votes were counted, and the results were prepared.
